The United States Court of Appeals for the Second Circuit invites applications for the position of Paralegal to a United States Circuit Judge.

POSITION OVERVIEW: The Paralegal is responsible for the day-to-day operation of chambers and performs administrative and legal duties as assigned by Judge Pérez. The Paralegal prepares a variety of legal material and correspondence; receives and organizes case files; provides proofreading and editing assistance; arranges filing of orders and opinions; works with the law clerks to update and maintain the chambers case-tracking spreadsheet; schedules appointments and meetings on behalf of the Judge; makes travel arrangements and handles travel reimbursement; assists with submitting the Judge's annual financial disclosure report; assists with the hiring and onboarding of law clerks and interns; performs assorted receptionist tasks; helps with the planning and hosting of chambers and court events; maintains supplies and oversees chambers organization; maintains filing systems; and performs a variety of confidential tasks at the request of the Judge.

REQUIRED QUALIFICATIONS: Applicants must possess (1) a bachelor's degree or paralegal certificate from an accredited program and (2) one to three years of specialized work experience.* The candidate will be required to exercise a high degree of interpersonal skill in dealing with court staff, other judicial chambers, federal agency officials, and the public. Qualified applicants must also possess: superlative technical, organizational, verbal and written communication skills, including superior editing and proofreading skills; the ability to perform keyboard entries neatly and accurately; and demonstrated ability to understand material contained in legal opinions and orders and the ability to prepare correspondence, and to make revisions under time constraints as required. Proficiency in Microsoft Word, WordPerfect, Excel, and other computer programs is required; familiarity with an electronic case filing management system is preferred. The candidate will have the ability to thrive and lift up others in an environment that is mission-centered, deadline-driven, team-based, and highly dynamic. Discretion and the ability to maintain confidentiality are essential.

*Specialized work experience is defined as progressively responsible experience that is in or closely related to the work of the position that has provided the particular knowledge, skills and abilities to successfully perform the duties of the position. A Juris Doctor (JD) from an ABA-approved law school may be substituted for some specialized work experience.
